**Supreme Court Final Hearing on Tuesday, January 08, 2019 on  
the 'NGT Buffer Zone Judgement' of Bellandur - Agara Lake**

**Namma Bengaluru Foundation is a Petitioner and fighting in this case crucial to  
protect critical lakes and water bodies of Bengaluru**

**Bengaluru, January 06<sup>th</sup>, 2019:** The Supreme Court has fixed **January 08, 2019** for hearing final arguments on the Lake Buffer Zone Judgement by NGT. The State Government and the group of builders have decided to bring in a volley of legal-heavy weights in their attempt to quash the NGT Judgement.

On May 04, 2016, the NGT, Principal Bench passed a judgement specifying buffer zone of 75 metres in case of lakes, 50 metres for primary, 35 metres for secondary and 25 metres for tertiary rajakaluves to be maintained from the edge of these water bodies. The NGT observed that these buffers are absolutely essential for sustainable development of the environment of the area in question. These buffer zones were directed to be maintained as green belts, and as 'no construction zone' for all intent and purposes.

While this judgement is critical to restoring our lakes and environment- Mantri Tech Zone, Coremind Software Services and the State Government have approached the Supreme Court seeking to quash the NGT judgement.
